RE: White House Initiative on Women's Health Research – Information and Meeting Request

Dear Dr. Mazure and Ms. Klein,

On behalf of the American Urogynecologic Society (AUGS), I write to commend President Biden, First Lady Dr. Jill Biden, and the White House Gender Policy Council for the launch of the new White House Initiative on Women's Health Research and request a meeting with you for the leadership of the AUGS Scientific Committee to discuss the research needs for Pelvic Floor Disorders. AUGS recently completed the attached National Urogynecology Research Agenda for Advancing the Treatment and Management of Pelvic Floor Disorders. This agenda is also supported by several other national societies with an interest in women's health and Pelvic Floor Disorders.

AUGS is a national medical society whose mission is to promote the highest quality of care in female pelvic medicine and reconstructive surgery through excellence in education, research, and advocacy. AUGS represents more than 2,000 members, including practicing physicians, nurse practitioners, physical therapists, nurses and health care professionals, and researchers from many disciplines.

AUGS recognizes the importance of understanding and evaluating the conditions that women face throughout their lives, including conditions that become more prevalent in the post-reproductive years. The urogynecology community also recognizes that women's health research is woefully underfunded, and that most of the limited funding goes to research involving reproductive-aged women. AUGS believes women's health care should encompass the full life span of women, including conditions affecting post-reproductive and geriatric women, the fastest growing segment of the U.S. population. The CDC reports that over 50% of women aged sixty-five and older suffer from incontinence. Incontinence associated with overactive bladder, stress urinary incontinence and voiding dysfunction takes an economic and emotional toll on individuals and has a significant fiscal impact on society.

To acknowledge the need for increased research funding directed towards women's health, beyond maternity and reproductive care, AUGS has established the National Urogynecology Research Agenda that identifies knowledge gaps and research priorities across six topic areas:

Lower Urinary Tract Symptoms/Urinary Incontinence
Pelvic Organ Prolapse
Fecal Incontinence
Recurrent Urinary Tract Infections
Sexual Health in Women with Pelvic Floor Disorders
Bladder Pain Syndrome/Interstitial Cystitis and Myofascial Pelvic Pain

The research agenda also incorporates important cross-cutting themes related to health disparities, multidisciplinary research, and training future scientists.

AUGS representatives would greatly appreciate the opportunity to meet with you or your designated representatives to discuss this research agenda and how we can work together to fill the knowledge gaps and pursue promising research opportunities to address the health issues that impact millions of women in this country in their post-reproductive years. We will follow up to further discuss setting up and meeting and providing additional information and answering your questions.
